Terrell, husband and wife, of 2865 Sherwood Drive, Traverse City, Michigan 49684, convey and warrant to Torch Lake Development, Inc., a Michigan Corporation, of 603 Bay Street, Traverse City, MI 49684 land in the Township of Torch Lake, Antrim County, and State of Michigan, described as:

Part of Government Lots 1 and 4, Section 24, Town 31 North, Range 9 West, described as: Commencing at the North quarter corner of said Section 24; thence North 88\*57'00" East, 325.99 feet; thence South 0\*08'00" East, 1062.67 feet; thence South 88\*49'00" East, 345.12 feet, to the Southeast corner of Block 8 of the recorded Plat of the Village of Torch Lake; thence North 89\*52'52" East, 66.00 feet, to the Southwest corner of Block 7 of said recorded plat, being the point of beginning; thence East along the South line of said Block 7; a distance of 356.87 feet; thence South, parallel with Prospect Street 179.93 feet to the center line of a County Road; thence South 82\*18'30" East, along said centerline 11.23 feet; thence South 33.30 feet to the South line of said road; thence South 82\*18'30" East along the South line of said road 280.50 feet to the shore of Torch Lake; thence South road 280.50 feet to the shore of Torch Lake; thence South
